**Account Management and Remedies:** In the event it becomes necessary for Anaheim Automation, Inc. to file suit to enforce payment of past due invoices, such a suit will be brought in Orange County, California, USA. Anaheim Automation, Inc. shall be entitled to collection of fees, court costs, and interest at 10% per annum or such legal maximum rate as is allowed, on all invoice amounts past due.
